Great things for 2010

2010 promises to be a great year for the Academy for Sports Dentistry (ASD) as our membership continues to grow and our exposure expands. Our winter board meeting was extremely productive as we finalized details for our new website, which was launched at the beginning of January. We have Ryan Salazar to thank for spearheading this project as well as Shelly Lott for helping in the transition from the old to the new. The new site (www.academyforsportsdentistry.org) is incredible! Ryan will give a brief "show and tell" of all that is now available for our members on the new website at our Annual Symposium in Washington, DC. You won't want to miss it!

Dr. Steve Mills was appointed as the new Director of the ASD Team Dentist course. Dr. Mills will be working with the faculty in updating our course that is scheduled to be presented at our 2011 symposium in Las Vegas. This year we will continue to work closely with the National Athletic Trainer's Association (NATA) as Dr. Jack Winters will be speaking as a representative of ASD at their Annual Conference in Philadelphia. NATA has informed us that they will be coming out early Spring with a statement supporting the Academy and recommending that dentists working in the capacity of a Team Dentist should be a member of the Academy for Sports Dentistry. We have also been asked by the American Dental Association to work with them as they are updating the standard 99 which is titled "Athletic Mouth Protectors and Material."

Our big news in 2010 is that the US Soccer Federation and US Lacrosse have recommended that mouthguards meet our guidelines of a "properly fitted mouthguard." These are the first two major sports governing bodies in the United States that have adopted this position. Also, starting in 2010 Major League Soccer is mandating that all Team Dentists in their league be members of the Academy for Sports Dentistry. This is the first professional sports league to take that stand. In the last five months there have been

numerous articles published dealing with sports dentistry. This shows the growing interest in our field. As you can see, there has been a lot of positive activity as the Academy positions itself as the major resource for Sports Dentistry.

With that being said, it is with great pleasure that I invite you to attend the 28th Annual Academy for Sports Dentistry Symposium to be held at the Ritz-Carlton Pentagon City, June 24-26, 2010. This is an outstanding location just minutes away from Capitol Hill, downtown Washington DC, Arlington National Cemetery, National Monuments and Smithsonian Museums. The hotel is located on the metro line which makes the nation's capital very accessible. Our General Chairperson, Dr. Michael Messina, has put together a terrific scientific program. Editor's Column

Good or Bad: You Choose

Any friend or colleague who knows me well knows that one of my preoccupations is studying the concept of rules for mandating mouthguard use for sports that don't usually demand it. It is often said by parents of an injured child, "Why don't they just make it a rule?" While this is an understandable reaction to a specific event, history has shown that rules are often made but are just as often rescinded. Many excuses are used when justifying the reversal of a rule but it is my opinion that simple dissatisfaction with the comfort and wearability of mouthguards is at the root of most complaints.

Giving athletes well made, effective and comfortable appliances could possibly solve the problem but let's face it, most athletes still don't go to their dentist for a quality mouthguard. They chose to go to a retail store to purchase a convenient and inexpensive mouthguard. Even if they went to their dentist it is no sure thing that their dentist would know a good mouthguard from a poor one.

In the past few years a concept has arisen which could be a partial solution to the lack of availability of custom fitted mouthguards for large numbers of athletes. The idea I am speaking of is to allow the athlete to purchase a kit at a retail store (or by mail) which allows them to obtain a custom fitted guard without a dentist. This kit usually consists of a formable tray into which a "putty-putty" impression material is placed. The athlete then takes an impression of his or her own teeth. Once set the impression is mailed to a laboratory where the impression is evaluated and is either returned to "try again" or poured up in appropriate stone to fabricate a heat pressure laminated mouthguard.

This process is much less expensive and time consuming than the procedure of going to a dental office. The laboratories making the guards are usually well equipped and experienced in making hundreds of mouthguards. There are only two major flaws: 1) the inability to critically evaluate the fit and occlusion of the finished guard and 2) the lack of any dentist involvement.

I have been so negative for so long about any process that excludes professional dental involvement that my initial reaction is not very supportive. But I am still annoyed at the Massachusetts Interscholastic Athletic Association's recent change of their basketball rule from a mouthguard mandate to a "high recommendation." I can't help but think that if more athletes had access to custom fitted guards it would have helped.

I've seen the guards made by these labs and they are good quality heat pressure laminated EVA mouthguards of a variety of thicknesses. I wonder at the overall quality of the impressions but I've done enough hands-on workshops to know that even dentists don't always take nice impressions. Also, most of these labs have a policy that if the impression is not adequate they give the customer a second chance.

My biggest issue is that I have become convinced that the occlusion of a mouthguard should be evaluated before the player uses it. This may or may not be critical for everyone but as someone with a somewhat unique "bite" (deep overbite, minimal overjet and relatively short clinical crowns) I know that I usually have to adjust any mouthguard of any thickness for my personal use

before I am comfortable with it. The research out of Japan also informs me that it is possible to create a potentially hazardous situation for the mandible if the occlusion is not balanced.

I guess I feel that these mouthguards are not a bad thing. If the sport for which they are used needs mainly dental protection and doesn't demand solid occlusal support they are probably fine. If

one of my patients brought one to me to adjust I would gladly do it. In fact, I would encourage the manufacturers to strongly suggest this in their instructions. This will make custom fitted mouthguards available to many more athletes.

The bottom line is that I still don't think that a mouthguard can be made and delivered optimally without professional dental evaluation even if it is very well made. Anything less "might" be fine but then again it might not. What do you think?

News Briefs:

Major League Soccer Requirements for Team Dentists

Major League soccer in the United States has mandated that all of the sixteen teams require that their team dentists be members of the Academy for Sports Dentistry and that the dentists have completed the Academy's Team Dentist Course. This is the first known effort to establish quality requirements for dentists who call themselves team dentists. It has been common practice in most sports to recruit dentists who are willing to be affiliated with different teams but whose background in sports dentistry is limited or non-existent. According to Emilio Canal of the DC United Soccer Team of Washington DC, "This rule does not imply that team dentists who have no formal connection with Sports Dentistry cannot be excellent team dentists. Rather it is a move to insure that the athletic trainers and the medical staffs of the teams can be confident that the dentists have the basic background to know what being a team dentist means and have the ability to fulfill this role." The rule will take effect for the 2010 season. More information about major league soccer can be found at www.MLSnet.com.

The November 2009 issue of the newsletter of the National Athletic Trainers Association, NATA

News, has published the content of the well known "pink trainers card" produced by the Academy for Sports Dentistry. 

Changes to the Constitution of the Academy for Sports Dentistry

The Constitution and Bylaws Committee brought several motions to the Board of Directors at the December 2009 board meeting amending the Constitution and Bylaws. The Board considered these amendments and voted to bring them to the membership for a vote at the annual meeting in June 2010. In accordance with Article XIII Section 1 of the ASD Constitution, any changes to the constitution must be published in the official publication of the ASD (The Newsletter of the ASD) "at least 60 days prior to the Annual Session of the Academy." The amendments are listed below.

CONSTITUTION

ARTICLE VI – OFFICIALS

Section 5. **Unscheduled Vacancies.**

Should the President of the organization be disabled or unable to perform his duties, his position shall be filled by the President Elect for the remainder of the unexpired term of his office. Should the President Elect be disabled or unable to fulfill his term of office, *the President shall appoint an interim President Elect for the unexpired portion of the President Elect's term.* This appointment shall be made from the members-at-large on The Board of Directors. *Shall the Secretary or Treasurer become disabled or unable to fill his term of office, the President shall make an interim appointment to fulfill the remaining portion of the term. This appointment shall be made from the members-at-large on The Board of Directors. In the event that there is no available members-at-large on The Board of Directors available to fulfill these positions, the office shall remain vacant and the additional duties assumed by the remaining officers until an election may be held for the purpose of filling the vacant positions.*

ARTICLE VIII - NOMINATIONS AND ELECTIONS.

Section 2. **Nominations by Petition**

Additional nominations may be made by a petition, signed by five **active** members of the organization **and the nominee** and received by the **Executive**

Secretary, at least ~~five~~ **fourteen** days before the annual meeting at which the elections take place.

CHAPTER V: COMMITTEES

Section 1. **Names and Number of Standing Committees.**

The organization shall have ~~seven~~ **eleven** standing committees designated as follows:

- A. Executive
- B. Constitution and By-Laws
- C. Membership and Credentials
- D. Research
- E. Publications
- F. Annual Session
- G. Nomination
- H. Past President/Strategic Planning**
- I. Student Affiliate Program**
- J. Special Olympics/Special Smiles**
- K. Fundraising**

Section 5. **Duties of Standing Committees.**

The following shall be duties of the standing committees of the organization:

- G. Nominating Committee. This committee shall make nominations for all elected officers of the organization. The nominating committee shall attempt to select its candidates on a diversified basis. The nominating committee will be composed of the immediate past president (chairman), the President Elect, **and the President** and will be in consultation with the rest of the Board of Directors.

CHAPTER VIII: ELECTIONS

Section 1. **Elections.**

Elections shall be held at the business meeting during the annual official session, at which time

there shall be elected the President Elect for a one year term. There shall also be elected two directors of the organization for a three year term. The Secretary and the Treasurer will be elected at the same session on the years those terms fall due. The Secretary and the Treasurer will be elected for a term of three years and may be elected for ~~one~~ **two** additional three year terms.

Section 2. Nominations.

Nominations made in accordance with Chapter IV, Section VII, shall be made by the nominating committee whose list of recommended candidates shall be published and distributed to the membership prior to the annual official session. Nominations may also be made by ~~any active members of the organization~~ **petition** provided **that** such nominations are made in writing, signed by **five active members and** the nominee. ~~endorsed by two other active members, and delivered~~ **The**

petition must be received by ~~to~~ the Executive Secretary ~~five~~ **fourteen** days **prior to the start of the annual meeting at which the election takes place** ~~in advance of the election~~. The list of all proposed candidates shall be posted by the **Executive** Secretary in a conspicuous place at the annual official session.


Issues of Dear Doctor Sports Dentistry Issue Available

It does however, contain topics, which are of interest to doctors, hygienists and both medical and dental personnel. Several members of the ASD and the IADT were involved in the production of this issue and the result is a highly professional and useful resource to give to parents, coaches, athletic trainers, school nurses and athletes who have questions about the connection between sports and dentistry.

Doug Harvey, Major League Umpire and Advocate against Smokeless Tobacco, Voted to the Hall of Fame

Doug Harvey, former major league baseball umpire, was voted into the National Baseball Hall of Fame in Cooperstown, New York on December 7, 2009. Doug had an illustrious 31 year career as a major league umpire, which ranks him second only in longevity to Bill Klem in years of service and his 4,670 games is ranked third in major league history behind only Klem (5,374) and Tommy Connolly (4,769). He was ranked as the second greatest umpire in history by the Society for American Baseball Research in 1999 and in 2007 was named one of the 52 most influential figures in the history of sports officiating by Referee magazine.

In August of 1997 Harvey was diagnosed with throat cancer, which was attributed to his chronic use of smokeless tobacco. After his recovery he became a strong advocate against the use of smokeless tobacco addressing many different groups but especially to professional baseball players. He has spoken to the Academy for Sports Dentistry in Miami (2005) and Cincinnati (2004). His personal and very powerful message was very meaningful and important to the attendees of our annual sessions. His presentations also strongly emphasized that advocating against the use of smokeless tobacco is one of the key topics of importance to sports dentists in the U.S. His presentation to the Academy in Cincinnati was videotaped but at this time is not available for public access.

Doug's accomplishments on the baseball diamond are legendary but he also occupies a special niche within the field of sports dentistry. He is a man of powerful integrity and emotion. He and his wife Joy hopefully will allow members of the Academy

to call them friends. The Academy for Sports Dentistry congratulates Doug on this achievement, which is certainly the highest honor in the world of baseball. Doug has been a friend of the Academy for years now and I know of no one more deserving of this honor than him. Major League Baseball and the National Baseball Hall of Fame are both fortunate to have this distinguished gentleman as one of their representatives."
